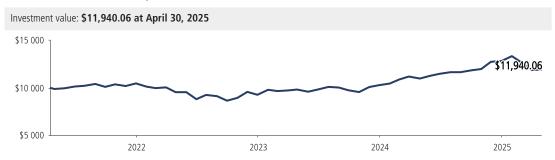

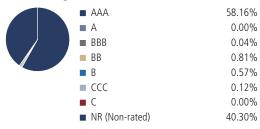
Sector Allocation



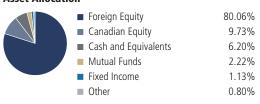
Geographic Allocation
